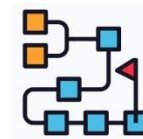

Show Me the Money: Tools for Understanding, Verifying & (Hopefully) Maximizing your SSI Allocation

The Ohio Department of Higher Education uses information from each school's HEI reports to allocate State Share of Instruction funds. While the overall model is relatively simple, the methodology for integrating HEI data into the model's components can be complex. Institutional Research staff at Ohio's public institutions need to be prepared to analyze SSI allocation reports. In this session, presenters will share tools they use to verify the accuracy of the reports and to communicate trends to their stakeholders. Each presenter will review one tool / report they use to analyze or audit SSI information. After all presentations, we'll take questions from the group and / or ask questions of the group to solicit additional ideas.

Q Methodology: An Introduction and Applications in IR

Ever heard of a Q-Sort and wondered if it might be useful for your work? Q Methodology combines the subjectivity of qualitative methods with the data analysis of quantitative methods. Because it speaks to both quantitative and qualitative audiences, Q Methodology can be a powerful and effective tool for research professionals who need to communicate with diverse constituencies. In this session, we'll introduce basics of using Q-Sorts, including planning steps, interpretation of results, potential uses, and resources for implementing them in your own project.

This session will be a brief introduction to Ohio labor market information. We'll talk about labor force statistics (including unemployment rates), the two kinds of industry employment data, and occupational employment and wage data. We'll end with an introduction to employment projections—forecasts of future job opportunities.

Many offices of institutional research are involved in supporting enrollment management, retention, forecasting, and projection efforts for their institution, but vary in the extent of their involvement and capacity. This session will highlight some of the ways institutions from the public 2-year, public 4-year, and private 4-year sectors inform planning, collect and manage data, and facilitate discussions around campus as to how to attract new students, retain new and current students, and plan for the future.

Each panelist will share their experiences, lessons learned, and nuances of their involvement with enrollment management projects at their institution, while reacting to questions from each other and session participants.

Using Graphic Organizers for Assurance of Learning

During accreditation reviews, universities must submit Assurance of Learning Programs many degree programs. Reading these can be an overwhelming task for reviewers if formatting is not standardized. One form of standardization is using software from vendors. Another solution is using graphic organizers consistently across reports to summarize key information. Graphic organizers can also be very useful as working documents for faculty to organize and summarize their work. Several examples of these graphic organizers will be shown and discussed. Attendees are encouraged to email their own examples to the presenter ahead of time so they can be displayed as part of the discussion.

Review of Training Investments and Job Development with the Economic Development and Employer Planning System (EDEPS), including the Postsecondary Employment Outcomes (PSEO) Beta Tool

Mark J. Schaff, Economic Development and Employer Planning System

This presentation will demonstrate the advantageous efficiency of the Economic Development and Employer Planning System (EDEPS at www.edeps.org) for reviewing quickly possible skill shortage occupations and related training programs, utilizing the EDEPS units of analysis (i.e., clusters) and sorting options. Furthermore, through the use of the EDEPS occupational/industry employment distributions and the link to employer directories, the presenter will provide examples of techniques to shorten job search time by unlocking the so-called "hidden job market" of non-posted, employment opportunities.

The first application of EDEPS to quickly identify possible skill shortage occupations for training investments is useful to educational program planners and researchers in their roles as human capital investors.

The second application of EDEPS to shorten job search time assists counselors and job developers in college career offices.

The presentation will conclude with discussions of the future of EDEPS, including improved supply information and the Postsecondary Education Outcomes (PSEO) beta tool of the U.S. Census Bureau (available through a link from the EDEPS website).
